Updates

Addressing Initiative

In an effort to increase exposure of the addressing standards and web-based interactive addressing interface, a power point presentation was provided to the METCAD Policy Committee on Thursday, October 1, 2015. The presentation was well received. METCAD and CCGISC plan to follow-up with a letter outlining the benefits of the Addressing Standards and Interface.

A quality control/assurance script was developed to help ensure the integrity of CC-RAD (*Champaign County Relational Address Database*). The script runs once a week and contains the following functionality:

- Removes unreferenced landmarks, points, street names and main addresses
- Removes duplicate addresses
- Removes unnecessary spaces in street names & landmarks
- Identifies addresses in wrong jurisdiction and zip code
- Identifies addresses that cannot be geolocated

CCGISC Website and ADA Compliancy

CCGISC Website

The CCGISC website – www.ccgisc.org – has been updated to include information regarding available CCGISC data layers as well as data purchase and release procedures. In addition, the site includes functionality to support the automation of data sales and data requests. ADA Compliancy

The CCGISC website was reviewed by an outside consultant for WCAG 2.0 compliancy as part of the ADA settlement agreement. Overall, the feedback was favorable however; the consultant identified a few required changes. Staff completed the changes and is currently altering the programming of the CCGISC Public Interactive Mapping Site in attempt to make it as ADA compliant as possible. The CCGISC website will be provided to the outside consultant for final review early in 2016.

ArcReader to ArcGIS Online Application Migration Progress

No additional ArcReader to ArcGIS Online application migrations occurred this quarter. The County Highway Department is slated for next quarter.

EMA/EOC Tornado Mock Training

Staff participated in a mock tornado event at the Emergency Operations Center (EOC) on Thursday, October 16, 2015. This was the first time GIS capabilities were utilized during a training exercise. To prepare for the event, staff compiled GIS data, maps, and step by step procedures. Care was taken to ensure the developed materials would be applicable to an actual tornado disaster. Based upon the lessons learned, staff will continue to refine the materials. In addition, staff is working to develop materials specific to a flood disaster.

GIS Recording Fee

The cost study analysis of the GIS recording fee resulted in a justified increase of \$5.00, increasing the GIS portion of the fee from \$9.00 to \$14.00. A memo was supplied to the County Administrator recommending the increase. The increase will be presented to the Champaign County Committee of the Whole (COW) in November. Should the COW recommend it for approval, the fee increase will be placed on the November County Board agenda.
